Lucía Quesada is PhD in Economics from the University of Toulouse (France) and holds an MA in Economic Policy and a Degree in Economics from the University of Buenos Aires (Argentina). Currently, she is a full-time professor and director of academic management at Universidad de San Andrés. She specializes in microeconomics, industrial organization, competition policy, and regulated markets. She has worked advising clients on issues related to market analysis, competition policy, regulatory framework revisions and impact evaluation. She has broad experience in several economic sectors, including means of payment, aluminum, cement, pharmaceuticals, transport, telecommunications, financial, electricity, ports, oil and gas, steel, waste management, and food and beverages, among others.
